Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ or direction more particularly one in the nature of writ of mandamus directing the respondents to pay the admitted billed amount in respect of the works executed by the petitioners i.e. such as "(1) Internal CC Road at Polaram (V) MP Mahamutaram, (2) C/O Padmashali Sangam Building at Ramulapally of Saidapur Mandal of Karimnagar District" under special development fund scheme with interest or 24% p.a. without reference to the

Memo.No.13/Pig.IX/SDF/2014, Dt-25-06-2014 of the 1st respondent by further declaring the entire action of the respondents in not making payments of the admitted billed amounts in respect of the above works executed by the petitioners as highly illegal, arbitrary, unjust, improper, colorable exercise of power.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to forthwith pay the admitted billed amounts in respect of the works executed by the petitioners such as "(1) Internal CC Road at Polaram (V) MP Mahamutaram, (2) C/o Padmashali Sangam Building at Ramulapally of Saidapur Mandal of Karimnagar District" pending disposal of WP.

ORDER:

Today when the matter has been taken up for hearing, learned counsel for the petitioners submits that this Court *vide* order dated 20.07.2016, has passed the following interim order:-

"As the petitioner claims that the amounts due are under admitted bills, there shall be a direction to the respondent authorities to verify and quantify the amounts due to the petitioner in terms of the works admitted and such undisputed amounts, if any, shall be paid to petitioners within four (04) weeks from the date of receipt of a copy of this order."

2. Learned counsel for the petitioners submits that subsequent to the interim order dated 20.07.2016, the respondent authorities paid the admitted billed amount to the petitioners and submits that no further orders are required in the Writ Petition. However, further submits that to the extent of claiming interest amount, liberty may be granted to the petitioners to seek appropriate remedy as available under law.

3. Learned Government Pleader's appearing for the respondents has not disputed the same.

4. Recording the submissions made by the learned counsel on either side, this Writ Petition is closed and to the extent of

claiming interest, if otherwise eligible, liberty is granted to the petitioners to seek appropriate remedy as available under law.

5. Accordingly, this writ petition is closed. Miscellaneous applications, if any pending, shall stand closed. No order as to costs.
