Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of mandamus, to declare the action of the Respondents in not permitting the Petitioner to discharge her duties as Anganwadi Teacher, consequent to her selection and appointment, through selection committee vide Proc.,No.ICDS/1A/171/2017 dt.21.03.2018 as illegal, unjust, arbitrary, Violative of Articles 14, 16 and 21 of the Constitution of India and consequently, direct the Respondents to permit the Petitioner to discharge her duties as Anganwadi Teacher, Elligaid-III (Vil), consequent to her appointment, through selection committee vide Proc.,No.ICDS/1A/171/2017 dt.21.03.2018,in accordance with

Rules with all service and monetary benefits, including arrears of salary from the date of her appointment.

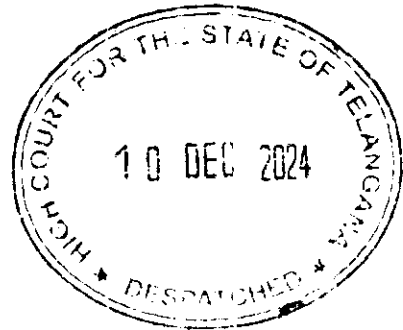
