Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the 2nd respondent in conducting public auction of the petitioners paddy 1266.262 Mts on 25.04.2023 is illegal, arbitrary, contrary to the Government Policy violation of the principles of natural justice and without jurisdiction fundamental rights guaranteed under the Constitution of India and consequently direct the respondents not to conduct public auction of the above said paddy

ORDER:

Today when the matter is taken up for hearing, there is no representation on behalf of the petitioner.

2. Heard learned Assistant Government Pleader for Civil Supplies appearing for the respondents and perused the record.

3. Learned Assistant Government Pleader for Civil Supplies appearing for the respondents submits that the petitioner filed the present writ petition questioning the action of the respondent No.2 in conducting public auction of the petitioner's paddy 1266.262 Mts on 25.04.2023.

4. At the stage of admission, this Court has not granted any interim order to stop the public auction conducted by the respondent-authorities and the said auction was completed. In view of the same, the cause of action does not survive and no further orders are required to be passed in this matter, thereby, the writ petition has become infructuous.

5. Having regard to the submissions made by the learned Assistant Government Pleader, this writ petition is dismissed as infructuous. No order as to costs.

6. As sequel to it, Miscellaneous Petitions, if any pending, shall stand closed.
