ORDER:

This Criminal Petition was filed by the petitioners/A2 & A3 to quash the proceedings in Crime No.537 of 2020 on the file of Chandanagar Police Station, Cyberabad. The offences alleged against the petitioners are under Sections 420, 406, 468 and 471 r/w.34 of the Indian Penal Code.

2. This Court by order dated 11.09.2020 granted stay of all further proceedings including arrest of the petitioners for a period of four weeks. Status of the investigation is not known. In the said circumstances this Court is not inclined to keep the petition pending.

3. Accordingly, the Criminal Petition is disposed off directing the police to conclude investigation without arresting the petitioners.

As a sequel, miscellaneous petitions, pending if any, shall stand closed.
