ORDER:

Heard Mr.Koushik Kanduri, learned counsel for the petitioner, learned Assistant Government Pleader for Energy appearing on behalf of respondent No.1, Mr. R. Vinod Reddy, learned Standing Counsel for TSSPDCL appearing for respondent Nos.2 to 5 and Mr.M.A.K. Mukheed, learned Standing Counsel for GHMC, appearing on behalf of respondent No.6.

2. The petitioner approached the Court seeking prayer as under:

" ... to issue any writ order or direction more particularly one in the nature of WRIT of MANDAMUS directing the respondents to act in accordance with law and to release service connections along with electrical meters to the petitioner herein for Plot bearing No.592 admeasuring 300 Sq.Yards in Sy.No.11/14 to 11/18 Part of Sy.No.11 situated in Sri Swamy Ayyappa Cooperative Housing Society Limited, Khanamet Village, Serilingampally Mandal, R.R. District without being influenced by the instructions of the 5th respondent and pass or orders as this Hon'ble Court deems fit and proper in the interest of justice"

3. When the matter is taken up for hearing, it is represented by both the learned counsel for the petitioner and learned Standing Counsel for TSSPDCL appearing on behalf of respondent Nos.2 to 5 that the subject issue in the present writ petition is squarely covered by the order of this Court dated 30.10.2023 passed in W.P.No.30005 of 2023, hence, the writ petition could be disposed of in terms of the order of this Court dated 30.10.2023 passed in W.P.No.30005 of 2023.

4. **Taking into consideration the submission made by the learned counsel appearing on behalf of the petitioner as well as the learned Standing Counsel appearing on behalf of respondent Nos.2 to 5, for the reasons alike in the above said order dated 30.10.2023 passed by this Court in W.P.No.30005 of 2023, the writ petition is disposed of directing the respondent Nos.2 to 5 to release the electricity service connection to the petitioner's Plot bearing No.592, admeasuring 300 Sq.Yards in Sy.No.11/14 to 11/18 Part of Sy.No.11 situated in Sri Swamy Ayyappa Cooperative Housing**

Society Limited, Khanamet Village, Serilingampally Mandal. R.R.District, within a period of four (04) weeks, from the date of receipt of a copy of this order and the same shall be subject to further direction that may be issued by the State of Telangana or the Apex Court in the litigation pending before it arising out of the order dated 12.09.2012 in Writ Petition No.20407 of 2008 and batch. However, there shall be no order as to costs.

Miscellaneous petitions, if any, pending in this Writ Petition, shall stand closed.

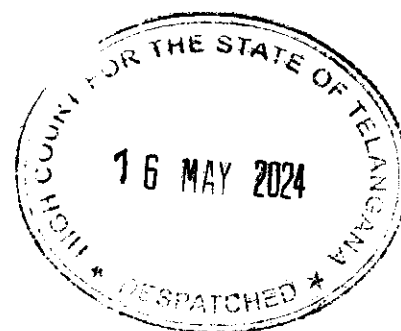
