Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ, declaring the action of the respondent No.2 and 3 in rejecting the petitioners application No.2300200519 submitted through Dharani on 11-03-2023 for succession/ mutation in respect of 3 acre 27 gts of land in Sy.No.208/Ee of Chigralpalle Village, Pargi Mandal, Vikarabad District, with assigning any reasons or communicating any order as illegal, arbitrary, against the principles of natural justice and against Article 300-A of Constitution of India and consequently direct the respondent No.2 and 3 for mutation/issuance of succession in respect of 3 acre 27 gts of land in Sy.No.208/Ee of Chigralpalle Village, Pargi Mandal, Vikarabad District and also issue pattedar passbook in respect of the above land.
