227/B and 238/A extent Ac. 0.20 Gts., Ac. 0.20 Gts., Ac. 2.07 gts., Ac. 1.02 ½ gts., Ac. 2.08 ½ Gts., total extent Ac. 5-18 Gts., situated at Mohammadapur Village, Husnabad Mandal, Karimnagar District, A.P. without any notice/ hearing that too without due process of law and award costs.

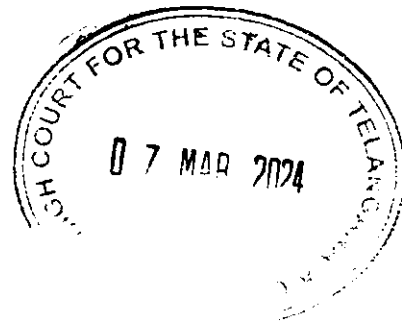
