2. No representation on behalf of the petitioner. Heard Mr.Jithender Rao Veeramalla, learned Additional Public Prosecutor appearing for respondent No.1-State.

Learned Additional Public Prosecutor, by filing the copy of e-Courts proceedings, would submit that the subject matter of C.C.No.1522 of 2020 is compromised before the III Additional Junior Civil Judge -cum- III Additional Judicial Magistrate of First Class. 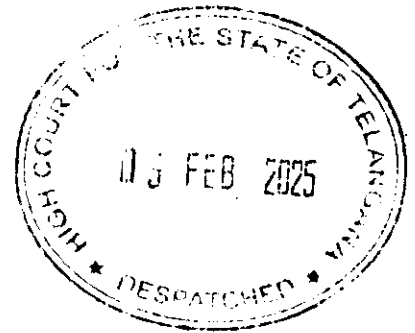
