ORDER:

This Transfer Civil Miscellaneous Petition is filed by wife for transferring of O.P.No.19 of 2023 from the Court of the II Additional Family Court, Medchal Malkajgiri District at Medchal to the Court of learned Family Court at Hanumakonda.

2. Heard learned counsel for the petitioner as well as learned counsel for the respondent. Perused the record.

Learned counsel for the petitioner submitted that the petitioner is residing with her parents at Hanumakonda and is becoming difficult for her to travel to Medchal- Malkajgiri District on each day of the hearing as she is unemployed and depending on her parents for eking out her livelihood and it is burdensome to her.
