Raghuram, learned counsel for the petitioner – wife would contend that in paragraph No.17 of the order, there is reference to the interim order dated 27.11.2012 in FCAMP No.700 of 2012 in FCA No.341 of 2012. Vide the aforesaid order, this Court considered the garnishee order and withheld an amount of Rs.2,00,000/-(Rupees Two Lakhs Only). This Court also considered withdrawing a sum of Rs.1,35,000/- (Rupees One Lakh Thirty Five Thousand only) by the wife and remaining amount of Rs.1,35,000/-</p> |                    |
