The Court delivered the following Judgment:

JUDGMENT:

This appeal is filed against the judgment and decree dated 15.12.2001 in O.S.No.121 of 1997 passed by the learned Family Court Judge, City Civil Court, at Hyderabad.

2. The suit vide O.S.No.121 of 1997 was filed for maintenance by the wife against her husband for dissolution of marriage, recovery of articles and for maintenance. The trial Court only granted permanent of Rs.75,000/- towards permanent alimony and other three reliefs were dismissed against which plaintiff in the suit preferred this appeal.

3. Learned counsel for respondent present.

4. It is informed that learned counsel for the appellant passed away on 08.12.2023 and the same was recorded on 28.11.2024.

5. As the appellant failed to take necessary steps to pursue the litigation even after listing the matter under the caption for dismissal, no purpose is served in continuing the appeal.

6. Accordingly C.C.C.A is dismissed for non-prosecution. t

As a sequel, miscellaneous petitions, pending if any, shall stand closed.

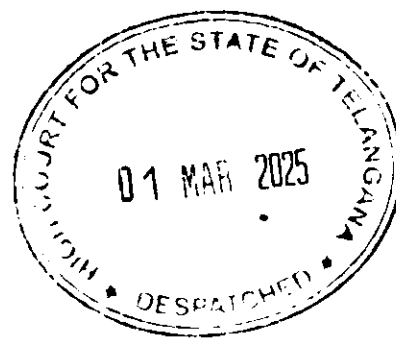
