JUDGMENT: *(per Hon'ble Sri Justice K.Surender)*

1. Earlier this Court dismissed the Appeal insofar as Accused Nos.1 to 3, 6 and 7 are concerned. The Appeal has to be heard insofar as A-4/Garlapati Shiva Kumar is concerned.

2. Today, when the matter is taken up for hearing, learned Additional Public Prosecutor produced a letter dated 30.12.2024 before this Court addressed to him by Sub-Inspector of Police, Malkajgiri Police Station and informed that A-4/Garlapati Shiva Kumar died on 19.12.2024. The death certificate of A-4/Garlapati Shiva Kumar is also enclosed along with the letter.

3. On account of death of A-4/Garlapati Shiva Kumar, the Appeal stands abated against him. The death certificate of A-4/Garlapati Shiva Kumar is made part of record.

4. Accordingly, the Criminal Appeal is dismissed as abated. Miscellaneous applications, if any shall stand closed.
