ORDER:

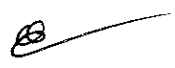

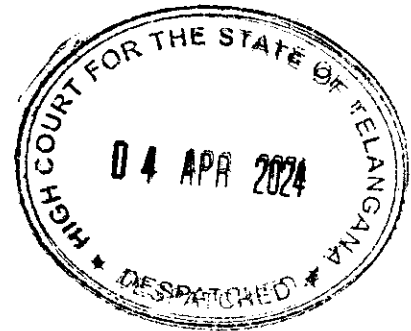
