ORDER:

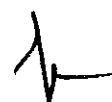

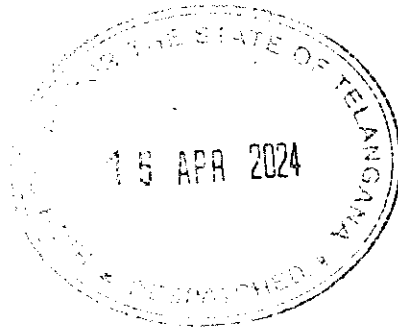
