Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declare the action of the respondents in not preparing a final seniority list of School Assistants and consequentially in not promoting the petitioner and other eligible candidates as PG Head Master Gr.II in the Scheduled Areas, by following the provisional seniority list of School Assistants, prepared vide R.NO.E1/999/2019, dated 15/10/2019, as per the schedule prescribed by the 3rd respondent as highly illegal, arbitrary and consequentially this Hon'ble Court may be pleased to direct the respondents to prepare a final seniority list of School Assistants working in ITDA, Eturunagaram and effect promotions to the posts of PG Head Master Gr.II in the existing vacancies.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct

the respondents herein to prepare a final seniority list of School Assistants by following the provisional seniority list dated 15/10/2019 and effect promotions to the posts of PG Head Master Gr.II in the existing vacancies in ITDA, Eturunagaram as per the schedule prescribed by the 2nd respondent pending disposal of the above writ petition.

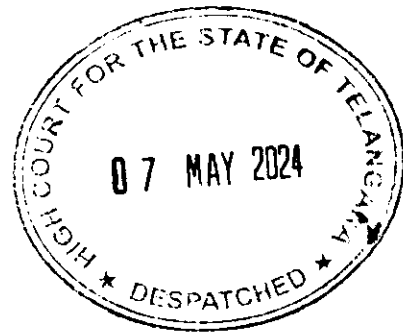
