Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of writ of mandamus declaring action of the respondent Nos. 2 and 3 herein in not initiating any action against respondent No. 7 U/s 32 (3) of Andhra Pradesh Cooperative Societies Act 1964 and in not completing the enquiry U/s 51 of Andhra Pradesh Cooperative Societies Act, 1964 be declared as illegal, arbitrary and violative of Article 14 of the Constitution of India and violative of principles of natural justice besides being violative of provisions of Andhra Pradesh Cooperative Societies Act and the Rules, 1964 and the byelaws of the Society with a consequential direction to respondent No. 2 and 3 to take action U/s 32 (3) of Andhra Pradesh Cooperative Societies Act 1964 against respondent No. 7, with a further direction to respondent No. 4 to complete the enquiry initiated U/s 51 of Andhra Pradesh Cooperative Societies Act 1964 and take action accordingly against Respondent No. 7, Chairman Primary Agriculture Co-operative Society, Thadvai, Munagala Mandal, Nalgonda District, in the interest of justice

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent No.4 to complete the inquiry u/s 51 of AP Cooperative Societies Act, 1964 against Respondent No.7, Chairman of Primary Agriculture Cooperative society, Thadvai, Munagala(M), Nalgonda District immediately with a further direction to Respondent Nos. 2 and 3 to take action thereafter accordingly in the interest of justice
