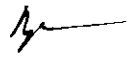
Party-in-person seeks permission of this Court to withdraw the contempt case with liberty to pursue his remedies in accordance with law.

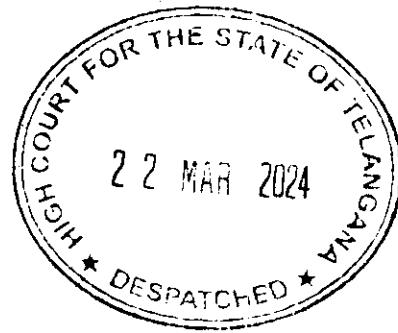
