Maldakal (M), Jogulamba Gadwal District on the file of the Principal Judicial First Class Magistrate at Gadwal for the offences under Section 146 and 107 of the Bharatiya Nyaya Sanhita and Sections 75 and 79 of the Juvenile Justice Act, Juvenile Justice (Care and Protection of Children) Act, 2015.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri Guduru Ashok Reddy, Advocate for the Petitioner and the Public Prosecutor on behalf of the Respondent.

This Criminal Petition is filed by the petitioner-accused under Section 482 of Bharatiya Nagarik Suraksha Sanhitha, 2023 (for short 'BNSS') seeking anticipatory bail to the petitioner in Crime No.193 of 2024 of Maldakal Police Station, Jogulamba Gadwal District, registered for the offences under Sections 146 of Bharatiya Nyaya Sanhitha (for short 'BNS') and sections 75 and 79 of the Juvenile Justice Act, 2015.

2. After arguing for some time, the learned counsel for the petitioner sought permission of this Court to withdraw the criminal petition.

3. Permission, as sought for, is accorded.

4. Accordingly, the Criminal Petition is dismissed as withdrawn.
