Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction more particularly one in the nature of WRIT OF MANDAMUS directing the respondents 2 to 7 to provide electricity connection Supply to 5Nos 3Ph each 5KW Domestic load on existing 1No.3Ph 5KW bearing SC NO 6335 03041 under Cat-8 making a total load of 30KW to the Building, Plot No.6 Southern Part, admeasuring 100 Sq.yards, Plot No.7, admeasuring 200 Sq.yards, Plot No.36, admeasuring 200 Sq.yards, and Plot No.37 Souther Part, admeasuring 100 Sq.yards, (total admeasuring 600 Sq.yards) in Survey Nos.597, Malikarjun Nagar, Abdullapurmet (M), Pedda Amberpet Municipality, Ranga Reddy District, T.S., bounded by North. Plot No.6 North Part and 37 North Part, South. 30 Wide Road, East. 33 Wide Road, West. 30 Wide Road. Without insisting upon occupancy certificate from the 8th respondent by holding that the refusal to provide electricity connection to the above referred premises is illegal and arbitrary.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents 2 to 7 to provide electricity connection Supply to 5Nos 3Ph each 5KW Domestic load on existing 1No.3Ph 5KW bearing SC NO 6335 03041 under Cat-8 making a total load of 30KW Connection to the Building, Plot No.6 Souther Part, admeasuring 100 Sq.yards, Plot No.7, admeasuring 200 Sq.yards, Plot No.36, admeasuring 200 Sq.yards, and Plot No.37 Souther Part, admeasuring 100 Sq.yards, (total admeasuring 600 Sq.yards) in Survey Nos.597, Malikarjun Nagar, Abdullapurmet (M), Pedda Amberpet Municipality, Ranga Reddy District, T.S., bounded by North Plot No.6 North Part and 37 North Part; South. 30 Wide Road, East. 33 Wide Road, West. 30 Wide Road. Without insisting upon occupancy certificate from the 8th respondent pending disposal of main writ petition and may deem fit and proper in the circumstance of the case.

ORDER:

Heard Smt. Thakur Roopa Singh, learned counsel appearing on behalf of the petitioners, learned Government Pleader for Energy, appearing on behalf of respondent No.1, Sri R. Vinod Reddy, learned Standing Counsel for TSSPDCL, appearing on behalf of respondent Nos.2 to 7 and Sri Ch. Jagannatha Rao, learned Standing Counsel for GHMC, appearing on behalf of respondent No.8.

2. The petitioners approached the Court seeking prayer as under:

"...to issue writ order or direction more particularly one in the nature of WRIT OF *MANDAMUS* directing the respondents 2 to 7 to provide electricity connection supply to 5Nos 3Ph each 5KW Domestic load on existing 1No. 3Ph 5KW bearing SC No.6335 03041 under Cat-8 making a total load of 30KW to the Building, Plot No.6 Southern Part, admeasuring 100 Sq yards, Plot No.7, admeasuring 200 Sq. yards Plot No. 36, admeasuring 200 Sq yards and Plot No. 37 Southern Part admeasuring 100 Sq yards total admeasuring 600 Sq yards) in Survey Nos.597, Malikarjun Nagar, Abdullapurmet (M) Pedda Amberpet Municipality,

Ranga Reddy District, T.S. bounded by North: Plot No. 6 North Part and 37 North Part; South: 30' Wide Road; East: 33' Wide Road; West: 30' Wide Road. Without insisting upon occupancy certificate from the 8th respondent by holding that the refusal to provide electricity connection to the above referred premises is illegal and arbitrary and pass...".

3. It is represented by the learned counsel appearing on behalf of the petitioners and the learned Standing Counsel for TSSPDCL appearing on behalf of respondent Nos.2 to 7 that the subject issue in the present writ petition is squarely covered by the order of this Court dated 03.10.2024 passed in W.P. No. 27467 of 2024, hence, the present writ petition could be disposed of in terms of the aforesaid order.

4. **Bringing the said submissions of both the learned counsel on record and for the reasons alike in the above referred order passed by this Court in W.P.No.27467 of 2024, dated 03.10.2024, the writ petition is disposed of at the admission stage, directing the respondents to provide electricity connection supply to 5No's 3Ph each 5KW Domestic load on**

existing 1No.3Ph 5KW bearing SC No. 6335 03041 under Cat-8 making a total load of 30KW to the Building, Plot No.6 Southern Part, admeasuring 100 Sq yards, Plot No.7, admeasuring 200 Sq. yards, Plot No. 36, admeasuring 200 Sq yards and Plot No. 37 Southern Part, admeasuring 100 Sq yards (total admeasuring 600 Sq yards) in Survey Nos.597, Malikarjun Nagar, Abdullapurmet (M) Pedda Amberpet Municipality, Ranga Reddy District, T.S., upon the petitioners complying with the required terms and conditions as per rules in force, and upon the petitioners furnishing an undertaking to produce the occupancy certificate from the Municipal Corporation concerned, within a reasonable period as prescribed by the respondent Authority and if no such occupancy certificate is produced by the petitioners within such prescribed time, it is open to the respondent Nos.2 to 7 to take appropriate action, in accordance to law. However, there shall be no order as to costs.

The miscellaneous applications, if any, shall stand closed. However, there shall be no order as to costs.

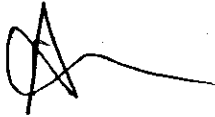
