Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to grant a Writ Order or Direction more particularly in the nature of Writ of Mandamus declaring the action of the Respondents in trying to interfere and disturb the existing physical features /semi constructed commercial building by demolishing the same on the Petitioners land i e land in Survey Nos 223 AA ,Door No.5-5/1, Sai Tulasi enclave-III admeasuring 1083 Sq.Yds or 905.38 Sq.Mts at Vattinagulapally Village Gandipet Mandal ,Narsingi Municipality, Rangareddy Dist without issuing any notice to the Petitioner as being illegal arbitrary highhanded apart from being violative of Articles 14, 19, 21 and 300A of Constitution of India and consequently direct the Respondents not to interfere in any manner whatsoever in the ownership physical possession and enjoyment of the Petitioner

over the subject land i e Survey Nos 223 AA ,Door No.5-5/1, Sai Tulasi enclave-III admeasuring 1083 Sq.Yds or 905.38 Sq.Mts at Vattinagulapally Village Gandipet Mandal ,Nasingi Municipality, Rangareddy Dist including but not limited to disturbing the existing physical features in any manner whatsoever existing thereon.
