Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction or writ more appropriately, a WRIT OF MANDAMUS, to declare the action of the Respondents herein in not paying any land compensation to the Petitioner in respect of his land over an extent of Ac. 5-15 guntas in Sy. No. 20 of Gullakota Village, Laxettipet Mandal, Adilabad District inspite of consent award passed by the 3rd Respondent and approved by the Joint Collector, Adilabad, vide his proceedings No. B6/527/07, dated. 12.10.2007, till date is illegal and further direct the Respondents herein to make payment of Rs.6,18,125/-(rupees six lakhs, eighteen thousand one hundred and twenty five only) along with interest at 18% per annum from the date of such approval till the date of payment to the Petitioner forthwith

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents herein to pay the land compensation to the Petitioner in respect of consent award passed by the 3rd Respondent as per the approved consent award proceeding No.B6/527/07, dated. 12-10-2007, for Rs.6,18,125/- (rupees six lakhs eighteen thousand one hundred and twenty five only) forthwith, pending disposal of the above writ petition
