Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of MANDAMUS declaring the action of the respondents in not paying the compensation amount to the petitioners for his acquired house plot extent 167 Sq. Yards bearing No. 194/B Sy.No.176, Muthangi Village, Patancheru Mandal, Medak District, acquired vide Draft Declaration No. D/ORR/145/05 Dated 18-4-2006 in Form 5-A u/s 6 of the L.A. Act, issued by the 2nd Respondent as illegal, arbitrary, violative of principles of natural justice and has the effect of violation of fundamental rights guaranteed to them u/a 14, 19 and 21 of the Constitution of India and consequently direct the Respondents to forthwith pay the compensation amount to the petitioner for his acquired plot extent 167 Sq. yards bearing No. 194/B Sy.No. 176, Muthangi Village, Patancheru Mandal, Medak District.

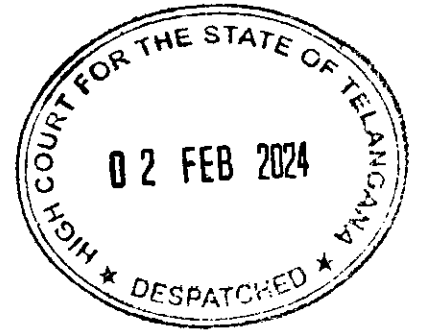
