Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction particularly one in the nature of Writ of Mandamus declaring the Impugned Order No.A/GP/2014-1 Dated 10.07.2014 issued by the 3rd Respondent directing the Petitioner not to undertake any construction in violation of construction permission already granted under the provisions of A.P. Panchayat Raj Act 1994 in Petitioners plot over an extent of 421.94 square yards in Sy.No.384/E situated at Pebbair Gram Panchayat and Mandal, Mahabubnagar District as totally illegal, without jurisdiction and consequently set aside the same by further directing the Respondents not to interfere with the Petitioners construction of house in accordance with the sanctioned plan as per the construction permission dated 30.12.2006 validated from time to time in accordance with provisions of the Act.

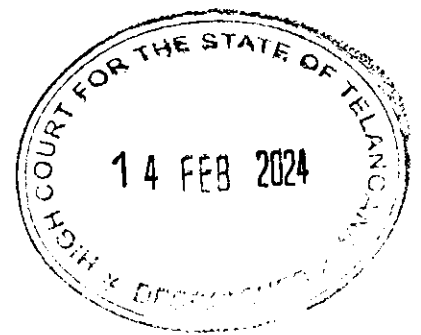
