Residential Building in Survey No.11/7, admeasuring Ac.05.00 (Non Agriculture) Gts, sq. yards, situated at Beside Grand Truck Road, Khanamet (V), Serilingampally (M), Ranga Reddy District, T.S., bounded by North. 100 Feet Road. South. Hotel Grand Trunk. East. 30 Feet Road. West. Neighbours land. And not providing electricity connection to the above referred premises as illegal and arbitrary.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents 2 to 7 to process the application of the Petitioner to provide for phase 3 Non-Domestic and Commercial connection, total Non-Domestic and Commercial Load of 5000 watts vide Reg.No. NR915244237766 connection to the petitioner Residential Building in Survey No.11/7, admeasuring Ac.05.00 (Non Agriculture) Gts, sq. yards, situated at Beside Grand Truck Road, Khanamet (V), Serilingampally (M), Ranga Reddy District, T.S., bounded by North. 100 Feet Road. South. Hotel Grand Trunk. East. 30 Feet Road. West. Neighbours land.

The Court made the following: ORDER

HON'BLE MRS. JUSTICE SUREPALLI NANDA

WRIT PETITION No.36869 of 2024

ORDER:

Heard Smt.Thakur Roopa Singh, learned counsel appearing on behalf of petitioner, learned Assistant Government Pleader for Energy, appearing on behalf of respondent No.1, Sri N.Sridhar Reddy, learned Standing Counsel appearing on behalf of respondent Nos.2 to 7 and Sri Raparthi Venkatesh, learned Standing Counsel for GHMC, appearing on behalf of respondent No.8.

2. The petitioner approached the Court seeking prayer as under:

"...to issue writ order or direction more particularly one in the nature of WRIT OF *MANDAMUS* declaring the action of the respondents in not processing the application of the petitioner to provide for phase 3 Non Domestic and Commercial connection, total Non-Domestic and Commercial Load of 5000 watts vide Reg.No. NR915244237766 connection to the petitioner in respect of the Residential Building in Survey No.11/7, admeasuring Ac.05.00 (Non Agriculture) Gts, sq. yards, situated at Beside Grand Truck Road, Khanamet (V), Serilingampally (M), Ranga Reddy District, T.S., bounded by North:100 Feet Road; South:Hotel Grand Trunk; East:30 Feet Road; West:Neighbours land. And not providing electricity

connection to the above referred premises as illegal and arbitrary and pass such order or other orders as this Hon'ble Court deem fit and proper in the circumstances of the case".

3. It is represented by the learned counsel appearing on behalf of the petitioner and the learned Standing Counsel appearing on behalf of respondent Nos. 2 to 7 that, the subject issue in the present Writ petition is squarely covered by the order of this Court dated 21.11.2024 passed in W.P.No.32661 of 2024 and hence, the present writ petition could be disposed of in terms of the aforesaid order.

4. **Taking into consideration the aforesaid facts and circumstances and the submissions put forth by both the learned counsel appearing on behalf of the petitioner and the learned Standing Counsel appearing on behalf of respondent Nos.2 to 7, the writ petition is disposed of at the admission stage directing the petitioner to make a fresh application within one (1) week from the date of receipt of a copy of the order along with all the relevant documents as mandated under the rules and on receipt of such application with all the relevant documents, the respondents shall consider the said application filed by**

the petitioner, for providing phase 3 Non Domestic and Commercial connection, total Non-Domestic and Commercial Load of 5000 watts vide Reg.No. NR915244237766 connection to the petitioner in respect of the Residential Building in Survey No.11/7, admeasuring Ac.05.00 (Non Agriculture) Gts, sq. yards, situated beside Grand Truck Road, Khanamet (V), Serilingampally (M), Ranga Reddy District, in accordance to law preferably within a period of two weeks thereafter, subject to the petitioner making necessary payment, as stipulated under the Electricity Act, 2003. However, there shall be no order as to costs.

As a sequel, the miscellaneous petitions, if any, pending in the Writ Petition shall also stand closed.

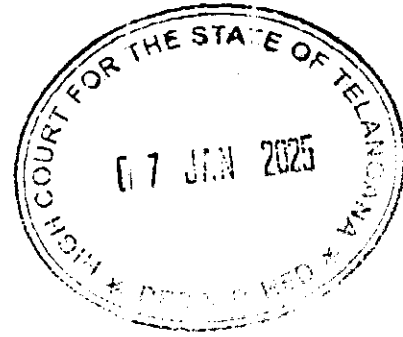
