The present Criminal Revision Case is filed aggrieved by the order dated 10.10.2018 passed in CrI.M.P.No.517 of 2017 in F.C.M.C.No.91 of 2017 on the file of the learned VI Additional District Judge, Khammam (for short, "the trial Court").

2. No representation on behalf of the revision petitioner/respondent. Mr. Jagadish, learned counsel for respondent Nos.2 and 3/petitioners is present. Heard Mr. Vizarith Ali, learned Assistant Public Prosecutor appearing for respondent No.1 State.

3. When the matter is taken up for hearing, the learned Assistant Public Prosecutor would submit that this Court vide order dated 27.04.2022 in CrI.R.C (SR) No.3198 of 2022 held that as against an interlocutory order, a Revision under Section 397 of Criminal Procedure Code is not maintainable and hence, sought for dismissal of the present Criminal Revision Case.
