2. Heard Sri Ravendher Reddy, learned counsel representing Sri K.Muralidhar Reddy, learned counsel for the petitioners.

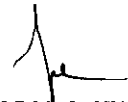

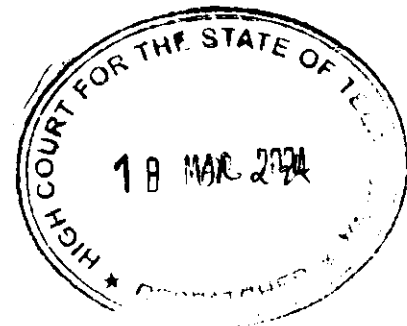
