In the present petition, the only grievance being raised by the
petitioner is that though the order of transfer dated 29.12.2023 (Annexure P-
2) has been withdrawn and the petitioner intends to participate in the transfer
process, which has been initiated by the respondents but the petitioner is
facing difficulty that her date of posting at the present place is being treated



as 16.01.2024 instead of 14.11.2017 and the respondents be directed to correct the same in the data so that petitioner can participate in the transfer process.

Learned counsel for the respondents on instructions from Sh. Lovish Chawla, Assistant Director, SA-2 submits that in case the petitioner visits the office of the DPI (Schools), Punjab, the petitioner will be helped with amending the said data so that petitioner can participate in the transfer process.

Learned counsel for the petitioner submits that petitioner will visit the office of the DPI (Schools), Punjab on tomorrow i.e. 02.08.2024.

Learned counsel for the respondents submits that all the help will be provided to the petitioner to correct the actual data qua the date of posting on the present place of posting of the petitioner to change it from 16.01.2024 to 14.11.2017.

With above observations, the present petition as well as **CM-11886-CWP-2024** is disposed of having been not pressed any further.

At this stage, learned counsel for the petitioner submits that salary for the certain period has not been extended and the petitioner intends to approach the respondents raising the said grievance and the respondents be directed to decide the said claim as well.

Learned counsel for the respondents submits that in case, any representation is received qua the claim for the grant of salary for any period, the same will be considered in accordance with law and an appropriate order will be passed within a period of eight weeks of the receipt of any such claim
