KARAMJIT SINGH, J. (ORAL)

1. The present petition has been filed by petitioner/complainant Jitender Pal Singh seeking cancellation of regular bail granted to respondent No.2 Gurpreet Singh in criminal case having FIR No.50 dated 07.03.2023 registered under Sections 384/506 IPC registered at Police Station Samrala by the Court of Additional Sessions Judge, Ludhiana vide order dated 22.05.2023 Annexure P-2.

2. The counsel for the petitioner submits that after the registration of the aforesaid criminal case, mother of respondent No.2 falsely implicated the present petitioner in criminal case having FIR No.124 dated 27.06.2023 under Section 323/365/34 IPC, registered at Police Station Gobindgarh Mandi. It is further submitted that respondent No.2 is extending threats to cause harm to the petitioner and thus, the bail granted to respondent No.2 vide order Annexure P-2 deserves to be cancelled.

3. On the other hand, the counsel appearing on behalf of respondent No.2 submits that FIR No.124 dated 27.06.2023 was registered against petitioner and some other persons in accordance with law, wherein the investigation is still going on. It is further submitted that in criminal

case having FIR No.50 dated 07.03.2023, respondent No.2 is regularly appearing and he never misused the concession of bail and that no ground is made out to cancel the bail order Annexure P-2.

4. The State counsel while assisting the Court submits that in the present case, after completion of investigation, challan stands presented and charges are framed against respondent No.2 and other accused and two prosecution witnesses are already examined and now case is fixed for remaining prosecution evidence.

5. From the aforesaid, it appears that after grant of bail, respondent No.2 is regularly attending the trial Court and has not misused the concession of regular bail in any manner and the trial is proceeding ahead and there is nothing available on the record to show that respondent No.2 has ever given threat to the petitioner to cause harm to him.

6. In light of the above, this Court is of the view that no ground is made out to cancel the bail order dated 22.05.2023 Annexure P-2 passed by the Court of Additional Sessions Judge, Ludhiana whereby the petitioner was granted regular bail in criminal case having FIR No.50 dated 07.03.2023 registered under Sections 384/506 IPC at Police Station Samrala, District Ludhiana.

7. Consequently, without expressing any opinion on the merits of the case, the present petition is hereby dismissed being devoid of merits.

8. Pending application, if any, stands disposed of.
