SUMEET GOEL, J.

1. By way of present petition, the petitioners are seeking quashing of FIR No.0192 dated 06.05.2023 under Sections 498-A, 406, 323 & 34 of IPC, registered at Police Station, City Barnala, District Barnala and all consequential proceedings arising therefrom on the basis of compromise dated 22.11.2023 (Annexure P-2), which is stated to have been effected between the parties.

2. On 12.02.2024, the following order was passed:

“The petitioners have approached this Court seeking quashing of FIR (Annexure P-1) and all consequential proceedings emanating therefrom on the basis of a compromise having been effected between the parties.

Notice of motion.

At this stage, Mr. Anup Singh, AAG, Punjab, has put in appearance on behalf of respondent No 1 State of Punjab and accepts notice.

Mr. Pankaj Bains, Advocate has filed vakalatnama for respondent No. 2. The same be taken on record.

The parties are directed to get their statements recorded qua the factum of compromise in the following manner:

(i) The petitioners shall appear before the trial Court/Illaqa Magistrate concerned on 16.02.2024 or any date thereafter as fixed by trial Court/Illaqa Magistrate for recording statement of the petitioners as well as of the complainant qua the factum of compromise. As and when any such appearance is made, the trial Court/Illaqa Magistrate shall do the needful for recording the statements of the parties qua the factum of the compromise. It shall be open to the trial Court/Illaqa Magistrate to either record the statement of the parties by physical process or by video conferencing as deemed appropriate by the trial Court/Illaqa Magistrate.

(ii) In case the statement is to be recorded by way of video conferencing,

the parties concerned shall be duly identified through video conferencing by their respective counsel, subject to the satisfaction of the Presiding Officer.

(iii) The trial Court/Illaqa Magistrate may also choose to get the statements of the parties recorded through some Commissioner, appointed by the Court who would be some Advocate having sufficient standing at the Bar. In case the statement is recorded through some Commissioner, such Commissioner/Advocate shall furnish an affidavit after recording statements to the effect that the parties had appeared before him/her and he/she had recorded their statements as per law and that the said parties had been duly identified by their respective counsel. This shall be subject to satisfaction of trial Court/Illaqa Magistrate.

After recording the statements of all the affected parties in either of the aforesaid manner, the trial Court/Illaqa Magistrate shall submit its report

on the basis of the statements so recorded as to whether all the affected parties have entered into a compromise and as to whether the compromise in question is found to be a valid compromise and has been effected without there being any kind of influence or coercion.

The trial Court/Illaqa Magistrate shall also report as regards the following facts after seeking information from Investigating Officer, concerned:

(i) Whether there is any other accused other than the petitioners, arrayed in this petition.

(ii) Whether there is any other complainant or affected/ aggrieved party other than the respondents, arrayed in the petition.

(iii) Whether any accused has been declared Proclaimed Offender?

The report be submitted before this Court before the next date of hearing i.e.12.03.2024.”

3. Pursuant to the aforesaid order, report dated 11.03.2024 from Judicial Magistrate Ist Class, Barnala has been received, which is taken on record. As per the report, the Trial Court has recorded as follows:-

“1. I have the honor to submit that vide order dated 12.02.2024 of Hon'ble High Court, passed in the subject cited petition, this Court has been directed to submit a report on or before next date of hearing containing the following

information as well :-

1) Whether there is any other accused other than the petitioners, arrayed in this petition

2) Whether there is any other complainant or affected/aggrieved party other than the respondents, arrayed in the petition.

3) Whether any accused has been declared proclaimed offender?

2. Accordingly both the parties i.e. complainant namely Kajal wife of Vishal Singla and accused person namely Vishal Singla son of Raj Kumar, Saila Singla @ Payal Singla daughter of Raj Kumar and Chander Prabha wife of Raj Kumar appeared in the Court for getting their statements recorded regarding compromise effected between them. Complainant Kajal suffered separate statement to the effect that complainant got registered one case FIR No.192 dated 06.05.2023 against Vishal Singla along with other dated 06.05.2023 accused persons array been

been accused person namely Salla Singla @ Payal Singla, ChanderPo under Sections 498A, 406,323, 201 and 34 of Indian Penal Code. 1800 Police Station City Barnala. She further submitted that she ha compromised the matter with accused persons as mentioned above with Intervention of respectables. She has no grudge against the accused persons. She has compromised the matter voluntarily and without any fear, force, Pressure and coercion. She has no objection in case the above FIR against the accused persons/petitioners be quashed. She further placed on record the copy of compromise deed as Ex.C1. Accused persons/petitioners also suffered similar statement. They further stated that the present FIR may be quashed on the basis of the compromise.

3. Statements of ASI Gursimranjit Singh No634/BNL. i.e. Investigating Officer of the case was also recorded, who stated that FIR No.192 dated 06.05.2023 under Sections 498A, 406,323, 201 and 34 of Indian Penal Code, 1860 at Police Station City Barnala, was registered at the instance of complainant/respondent no.2 against accused persons/petitioners namely Vishal Singla along with other accused person namely Saila Singla @ Payal Singla, Chander Prabha. Only complainant Kajal is the complainant in the present case and there are three accused persons involved in the present case. Accused persons are not declared proclaimed offender in any other case and their custody is also not required any other case. None of the accused is previous convict and no other case is pending against the petitioners and respondent no. 2.

4. From the statements of both the parties as well as the investigating officer of the case, the compromise appears to be genuine, valid, voluntary and without any pressure, coercion or undue influence. In case FIR No.192 dated 06.05.2023 under Section 498A, 406,323 201 & 34 of IPC, three accused persons namely Vishal Singla, Saila Singla, Chander Prabha have been arrayed as accused. All the accused and the complainant/injured have been made party in the petition before the hon'ble High Court. Further, except complainant Kajal, no other person is the complainant and victim in the present case. The parties in the present petition are neither previous convict nor any case is pending against them. None

of the parties involved in this case is ever declared proclaimed offender.

5. This present report is accordingly submitted please, for onward transmission to the Hon'ble Punjab and Haryana High Court for kind information and necessary action. Photocopies of statements so recorded are also enclosed herewith, for kind perusal please."

4. Learned counsel for respondent No.2 admits the fact of parties having compromised and states that he has no objection in case the FIR and all proceedings subsequent thereto against the petitioners are quashed.

5. Similarly, learned State counsel has stated no objection in case the FIR is quashed based upon the compromise (Annexure P-2).

6. I have heard learned Counsel for the parties and have carefully gone through the records of the case.

7. This Court and the Hon'ble Apex Court has repeatedly dealt with the issue of exercise of jurisdiction under Section 482 of the Code to quash proceeding in non-compoundable offences in the cases of ***Gian Singh vs. State of Punjab and another, 2012(10) SCC 303, Kulwinder Singh & others vs. State of Punjab & another, 2007 (3) RCR (Criminal) 1052 and Ram Gopal and another vs. State of Madhya Pradesh, 2021(4) R.C.R. (Criminal) 322 (Criminal Appeal No.1489 of 2012 decided on 29th of September, 2021).*** The proposition of law that emerges from the aforesaid decisions rendered by the Hon'ble Apex Court and this Court is :

- (a) Power u/s 482 Cr.P.C. vested with this Court is much wider and is unaffected by Section 320 of the Code.*
- (b) However, wider the power greater the caution.*
- (c) The underlining principle while exercising such power is that it can be invoked to quash the proceedings recognizing compromise between the parties in the matters which are overwhelmingly and predominantly of civil character like commercial*

transactions or arising out of matrimonial relationship or family disputes.

- (d) The said power is not to be exercised in the prosecutions involving heinous and serious offences of mental depravity or offences like murder, rape, dacoity etc. as such offences are not private in nature and have a serious impact on society.*
- (e) Section 482 Cr.P.C. casts duty upon the High Court to advance interest of justice as well. It is in recognition of this duty casted upon the High Court, that Apex Court held that the High Court would not refuse to quash FIR under Section 307 merely because FIR finds mention thereof. High Court can assess nature of injuries sustained, whether such injuries inflicted on vital/delicate parts of the body/nature of weapons used etc.*
- (f) Such exercise at the hands of High Court would be permissible only after the evidence is collected after investigation and chargesheet is filed/charges framed during the trial. Such exercise cannot be carried out while the matter is still under investigation.*
- (g) While quashing FIR in non-compoundable offences even which are of private in nature, High Court is required to consider antecedents of the accused, conduct of the accused and whether he was absconding or whether he has managed the complainant to enter into a compromise.*

8. Thus, keeping in view the aforesaid facts and circumstances, this Court is of the considered opinion that it is a fit case to exercise jurisdiction vested u/s 482 Cr.P.C. to quash the FIR as :-

- (i) Putting a quietus to the proceedings will bring peace and tranquility amongst parties & will accordingly further the cause of substantial justice.*
- (ii) The offences alleged are primarily of private nature.*

- (iii) *The parties have compromised.*
- (iv) *As per the report received the compromise is said to be voluntary in its nature.*
- (v) *Complainant/victim is reported to have entered into compromise on his own volition.*

9. Consequently, the petition is allowed. FIR No.0192 dated 06.05.2023 under Sections 498-A, 406, 323 & 34 of IPC, registered at Police Station, City Barnala, District Barnala and all consequential proceedings arising therefrom on the basis of compromise dated 22.11.2023 (Annexure P-2), are, hereby, quashed qua the petitioners.

10. Pending application(s), if any, shall also stand disposed off.
