1. There was no representation on behalf of the petitioners on the last date of hearing i.e. 07.11.2022 and even today also the position is the same.

2. The instant petition has been filed by the petitioners under Articles 226/227 of the Constitution of India, claiming the following relief :-

“A writ in the nature of mandamus directing the respondents particularly respondent No.2/Selection Board, Haryana to disclose the merits, marks, the details of the selected, unselected or waiting list candidates such as name and parentage, criteria and other minimum required details relating to the selection for comparison pursues for the post of Junior Engineer (Civil) for various Boards/ Corporation and Department Haryana and the same be either published or put on the website qua Cat. No.01, 04, 05, 10, 11, 12, 14, 16, 18, 20, 22, 23, 24, 25, 29, 30, 32 and

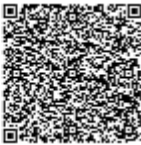

34 against advertisement No.10/2019 dated 15.06.2019 (ANNEXURE P-1) by virtue of order dated 22.05.2014 passed by this Hon'ble Court in CWP No.2201 of 2014 titled as Vikas Sharma and State of Haryana and others (ANNEXURE P-6) as the respondent no.2 only published individual result vide notice dated 18.06.2021 (ANNEXURE P-7) which is not sufficient for the comparison purpose and petitioners wants the detailed results of the selected candidates or unselected candidate like the result published by the respondent no.2 against the post of Sub Inspector (Female) (ANNEXURE P-8), in the interest of justice.”

3. In the short reply filed on behalf of respondent No.2, it has been stated as under :-

“xx xx xx xx xx

5. That the main contention of the petitioners in the present writ petition is to disclose the merits, marks, the details of the selected, unselected or waiting list candidates such as name and parentage, criteria and other minimum required details relating to the selection for comparison purposes for the post of Junior Engineer (Civil) for various Boards/Corporation and Department Haryana and the same be either published or put on the website qua Cat. No. 01, 04, 05, 10, 11, 12, 14, 16, 18, 20, 22, 23, 24, 25, 29, 30, 32 and 34 against advertisement no. 10/2019 dated 15.06.2019 (Annexure P-1). In this regard, it is submitted that the respondent Commission had already uploaded the details of the selected, unselected or waiting list candidates for the post of Junior Engineer (Civil) for various Boards/Corporation and Department Haryana on their website i.e. www.hssc.gov.in and the present writ petition may kindly be dismissed as the main prayer of the

petitioners regarding the uploading of the resut has already undertake by the answering respondent.

xx xx xx xx xx”

4. Learned State counsel submits that since the respondent-Commission has already uploaded the details of the selected, unselected or waiting list candidates for the post of Junior Engineer (Civil) for various Boards/Corporation and Departments, Haryana on their website, therefore, the instant petition has been rendered infructuous.

5. Since the relief claimed in the present petition has already been satisfied, therefore, the instant petition has been rendered infructuous and the same is disposed of accordingly.
