SANDEEP MOUDGIL, J (ORAL)

1. The jurisdiction of this Court under Section 482 Cr.P.C., has been invoked seeking directions to respondents No.1 and 2 to submit the action taken report qua the DDR No. 22 dated 25.06.2022 (Annexure P-1) registered on the complaint of the petitioner and for taking stern action by way of lodging an FIR under the attracted penal provisions, against respondent No.6 and his other associates.
2. Vide order dated 01.02.2024, respondent-State was called upon to file a status report and pursuant thereto, learned State counsel has filed an affidavit of Jatinder Singh, PPS, Deputy Superintendent of Police, Sub Division Kotkapura, District Faridkot, which is taken on record. Copy thereof, has been supplied to the counsel opposite.

Para Nos. 5 and 6 of the affidavit is relevant, which reads as under:-

“5. That in furtherance with the application, a board of doctors was constituted comprising Dr. Simranjit Singh, Dr. Puneet Kajal and Dr.

*Kewal Mohan and vide report dated 08.02.2024 have opined and declared the injury to be grievous in nature. Copy of final opinion is annexed as Annexure R-2.*

*6. That given the latest and final medical opinion, declared the injury of petitioner to be grievous in nature, attracted the ingredients of offence u/s 325 IPC. Consequent thereto investigation has been commended against Surat Singh and Baljinder Kaur afore-said with the registration of FIR No. 0018, dated 08.02.2024 under Sections 325/323/34 IPC at P.S. Sadar Kotkapura. Thus the present petition has rendered infructuous and liable to be dismissed.”*

3. In view of above, nothing survives in the present petition and the same is disposed off, as having been rendered infructuous.

4. Ordered accordingly.
