1. By way of present writ petition under Article 482 Cr.P.C., the petitioner has sought directions to the respondents No.2 to 4 to fairly and properly investigate and enquire into the cross-case bearing G.D. No.11 dated 25.11.2023 under Sections 323, 325, 326, 34 IPC in FIR No.395 dated 12.11.2023 under Sections 148, 149, 323, 506 IPC P.S. Chhapar, District Yamuna Nagar.
2. It is, *inter alia*, contended by learned counsel for the petitioner that the petitioner is having dispute with private respondents No.5 to 9 and in this regard FIR No. 395 dated 12.11.2023 under Sections 148, 149, 323, 506 IPC P.S. Chhapar, District Yamuna Nagar was registered and in the same case a cross-version vide G.D. No.11 dated 25.11.2023 under Sections 323, 325, 326, 34 IPC has also been registered.
3. Learned counsel for the petitioner further contends that the petitioner apprehends that the local police is in collusion with the accused party and as such seeks fair investigation into the matter. For this purpose,

he has moved a representation dated 16.01.2024 (Annexure P-9) to respondent No.2 but till date no action thereon has been taken. He submits that for the purpose of the petition, the petitioner will be satisfied if appropriate directions are given to respondent No.2 - Director General of Police, Haryana, Police Headquarter, Sector-6, Panchkula (wrongly mentioned as Yamuna Nagar) to consider and dispose of the representation (Annexure P-9) dated 16.01.2024 in accordance with law in an expeditious manner.

- 4. Notice of motion.
- 5. On the asking of the Court, Mr. Surender Singh, AAG, Haryana, present in Court, accepts notice on behalf of the State-respondents.
- 6. After hearing the respective submissions and also the averments made in the petition by learned counsel for the petitioner, without commenting on the purpose of the case, the present petition is disposed with a direction to respondent No.2 - Director General of Police, Haryana, Police Headquarter, Sector-6, Panchkula (wrongly mentioned as Yamuna Nagar) to consider and dispose of the representation dated 16.01.2024 (Annexure P-9) by the petitioner in accordance with law in an expeditious manner and the decision so taken be also intimated to the petitioner as well.
- 7. Decision so taken be intimated to the petitioner.
- 8. Disposed of.
