Present petition has been filed for quashing the impugned notice dated 05.03.2019 (Annexure P-2) issued by the Executive Officer, Panchayat Samiti, Kanina to the petitioners vide which a direction has been issued to the petitioners to remove their *pucca* shops within three months and notice dated 12/13.01.2021 (Annexure P-3) vide which the petitioners were directed to remove their shops within one week on receipt of the notice, failing which the same would be liable for damage. The said impugned notice is without following the proper procedure and the same is against their own letter/instruction dated 06.08.2018 (Annexure P-8) and against the settled proposition of law. Further prayer has been made for directing the respondents to shift the construction to the proposed land at Village Unhani where the land was already approved by the respondents for the said construction vide letter dated 18.07.2017 (Annexure P-4). Further prayer has been made for directing the respondents not to demolish the pucca shops of the petitioners which were constructed about 40 years back and are the only livelihood for the poor shop keepers.

Learned State counsel has submitted that the petitioners have not filed any reply to the show cause notice till date. She submits that in case, the petitioners file their reply to the show cause notice, the appropriate authority will decide the same after giving personal hearing to them.

Learned counsel for the petitioners has submitted that the petitioners have no objection if the said recourse is adopted. He has prayed that till the decision is taken by the competent authority, the petitioners be protected by granting interim protection.

Heard.

In view of the above submissions made by learned counsel for the parties, the present petition is disposed of with liberty to the petitioners to file their reply to the show cause notice within a period of four weeks from the date of receipt of certified copy of this order and in case, the reply as stated above is filed by the petitioners within the prescribed period, the competent authority will decide the same in accordance with law after providing them opportunity of being heard, within a period of two months from the date of filing of the reply by the petitioners.

Till the decision is rendered by the competent authority, no coercive action shall be taken against the petitioners. The petitioners will be at liberty to avail their remedy (by raising all pleas including lack of jurisdiction of Panchayat Samiti Kanina to issue notice) as per law.
