The Prayer in this petition under Article 226 of the Constitution of India is for issuance of writ of Habeas Corpus directing the official respondents to release the detenue namely Muskan who is in illegal detention of respondent nos.4 to 18.

On 05.03.2024 the following order was passed:-

“ Mr. Saurav Bhatia, Advocate has appeared and filed his vakalatnama on behalf of the petitioner today in the Court and the same is taken on record.

The alleged detenue namely Muskan Bano, who is present in the Court today wishes to reside with her husband petitioner-Salim Mohammad. They have stated that they wish to reside at Village Khorikhurd, Near Master Colony, Tehsil Tauru, District Mewat (Nuh), which is at a distance of approximately half Kilometre from the Police Post Khori Kalan, P.S. Sadar, Tauru, District Nuh.

Adjourned to 19.03.2024.

Till the next date of hearing, the petitioner and Muskan Bano are at liberty to reside at the residence as aforestated and the SHO of P.S. Sadar, Tauru, District Nuh shall ensure adequate protection to them in accordance with law.

As the family members of Muskan Bano are present outside the Court, 04 police officials namely SI Mahipal Singh, L/ASI Kukki, HGH Ratipal and HGH Inderjeet will accompany the petitioner and Muskan Bano providing them adequate protection enabling them to return to the place of their residence at Nuh.

The petitioner and Muskan Bano shall be present in the Court on the next date of hearing and the SHO of P.S. Sadar, Tauru, District Nuh shall ensure the protection for the same.”

In furtherance of the aforementioned order, the petitioner and Muskan Bano are present in court and states that they wish to reside together.

In view of the above, the present petition is disposed of with the directions to respondent nos.2 & 3 to ensure the protection of the couple in accordance with law.
