MAIN CASE

Prayer in the present petition is for directing the respondents to resolve the membership issue of the society before proceeding with the election of the governing body for the years 2024-26; and further for setting aside the order dated 08.01.2024 passed by respondent No.2- District Registrar of Firms and Societies, Faridabad.

Learned counsel for respondents No.6 to 11 contends that after the filing of the present writ petition before this Court, the petitioner has filed an appeal also, bearing No.11 of 2024 which is now fixed for hearing before the State Registrar of Firms and Societies, Haryana against the said order dated 08.01.2024 (also impugned herein). He further contends that insofar as the issue pertaining to the elections is concerned, the State Registrar of Firms and

Societies, Haryana has already passed an order in another appeal No.25 of 2024 filed by one another appellant namely Rajesh Ranjan, whereby the matter has been remanded to the District Registrar of Firms and Societies for taking a decision on the issue pertaining to the membership and a new Administrator has been appointed to take over the charge of management and affairs of the Society. He, thus, contends that insofar as the substantive prayer made for setting aside the order dated 08.01.2014 is concerned, the present petition has become infructuous on account of filing the appeal No.11 of 2024 by the petitioner before the State Registrar of Firms and Societies, Haryana, which is still pending and further owing to the fact that there is no immense urgency since a new Administrator has already been appointed and the District Registrar of Firms and Societies has been directed to resolve the issue of membership/ voter list.

Faced with the above, the counsel for the petitioner does not wish to press the present petition and seeks permission to pursue his proceedings already pending before the State Registrar of Firms and Societies, Haryana as well as the District Registrar of the Firms and Societies, Haryana.

Disposed of as not pressed with the liberty as aforesaid.
