1. By way of present petition filed under Section 482 Cr.P.C., prayer has been made for quashing the order dated 05.09.2023 (Annexure P-7) passed by learned Judge Special Court, Kapurthala, whereby bail of the petitioner was cancelled, besides, forfeiture of bail bonds as well as surety bonds, followed by issuance of non-bailable warrants against him.

2. Briefly stating, the petitioner was implicated in FIR No.248, dated 29.11.2017, registered under Section 22 of the NDPS Act, 1985, at Police Station Kartarpur, District Jalandhar (Rural), wherein he was granted the concession of interim regular bail vide order dated 16.03.2018 passed by the Court of Judge, Special Court, Jalandhar and thereafter, he was regularly appearing before the Trial Court, but for 05.09.2023, when the petitioner could not appear before the Trial Court, resulting into cancellation of bail and forfeiture of bail bonds as well as surety bonds followed by issuance of non-bailable warrants against him vide order dated 05.09.2023. The aforesaid order has been impugned by way of present petition.

3. Learned counsel for the petitioner submits that on account of

medical condition, the petitioner could not appear before the trial Court on 05.09.2023.

4. Notice of motion.

5. Mr. Kewal Singh, Addl.A.G., Punjab, who is present in Court accepts notice on behalf of the respondent-State and opposes the prayer while submitting that the non-appearance of the petitioner before the Trial Court was just to cause delay in the disposal of trial.

6. I have heard learned counsel for the parties and gone through the paper book.

7. The non-appearance of the petitioner before the Trial Court on 05.09.2023 appears to be unintentional and for bonafide reason i.e. on account of medical condition.

8. In view of the above, the present petition is allowed. Order dated 05.09.2023 is set aside. Petitioner is directed to appear before the Trial Court within a period of one week from the date of receipt of certified copy of this order and furnish his fresh bail/surety bonds, which shall be accepted, subject to its satisfaction. Till then, no coercive steps be taken against the petitioner.

9. The aforesaid order is subject to payment of costs of Rs.5,000/- to be deposited with the District Legal Services Authority, Kapurthala, Punjab, within a period of two weeks from today.
