The prayer in the petition under Section 482 Cr.PC is for quashing of the order dated 09.02.2023 (Annexure P-9) passed by the JMIC, Chandigarh in Complaint NACT No.4455/2021 dated 25.05.2021 under Section 138 of the Negotiable Instruments Act titled as M/s New Furniture Solutions Vs. M/s Om Narayan Constructions & Anr. vide which the petitioner has been declared a proclaimed person.

On 29.02.2024 the following order was passed:-

“ *The learned Counsel for the petitioner contends that the petitioner is ready and willing to effect a settlement with the complainant.*

Notice of motion for 11.03.2024.

Dasti as well.”

Thereafter on 08.04.2024 the following order was passed:-

“ **CRM-14688-2024**

Allowed as prayed for.



CRM-14689-2024

This is an application for placing on record reply to the petition by way of affidavit on behalf of the respondent.
For the reasons stated in the application, the same is allowed and the reply to the petition by way of affidavit on behalf of the respondent is ordered to be taken on record.

CRM-M-10823-2024

The petitioner is ready and willing to make the payment of the cheque amount along with requisite interest to the complainant on or before the next date of hearing.
Adjourned to 22.07.2024.”

As against the cheque amount of Rs.1,40,000/- a total amount of Rs.1,60,000/- stands paid to the complainant.

The Counsel for the petitioner and the counsel for the complainant submits that as a final settlement has been arrived at between the parties, the respondent would have no objection if the impugned order is quashed.

In view of the settlement arrived at between the parties, the impugned order dated dated 09.02.2023 (Annexure P-9) passed by the JMIC, Chandigarh in Complaint NACT No.4455/2021 dated 25.05.2021 under Section 138 of the Negotiable Instruments Act titled as M/s New Furniture Solutions Vs. M/s Om Narayan Constructions & Anr. stands quashed.

The respondents shall withdraw the complaint before the Trial Court in view of the compromise arrived at between the parties within a period of 04 weeks.
