The present petition has been filed under Section 482 of Cr.P.C.
for issuance of directions to respondent No.1-State of Punjab to hand over
the investigation of the case bearing FIR No. 1 dated 16.03.2010 under
Sections 406/420/120-B IPC registered at Police Station NRI, District
Nawanshahr to Special Investigation team headed by some senior IPS
Officer out of District S.B.S.Nagar.

Status report by way of an affidavit dated 27.08.2024 of Sh.
Ashok Kumar, PPS, Deputy Superintendent of Police, NRI Wing, Phase VII,
SAS Nagar was filed, wherein the following has been stated :-

*4. That it is submitted that thereafter the Additional
Director General of Police after preparing a report, wrote a letter
no. 439-5A/SP (Inves:) dated 19.02.2024 to Director Bureau of
Investigation, Punjab, Chandigarh for issuing the LOC against all
four accused persons.*

5. That it is worth to mentioning here that the basis of LOC, the accused Onkar Singh Saini and Jaswinder Kaur Saini, were detained by the Immigration Department Delhi, inside the Indira Gandhi International Airport, New Delhi on 5.06.2024, while they were coming from Canada to India. Thereafter, police party have arrested both the accused in the present case on 6.06.2024 at Airport New Delhi.

6. That it is submitted that thereafter, both the accused were produced before the Ilaqa Magistrate, SBS Nagar and the judicial remand was given till 20.06.2024 then they were granted bail by the Ld.Trial Court on 11.06.2024 and now both the accused are on bail.

7. That it is submitted that the challan under section 173 CrPC had been filed against the Onkar Singh Saini and Jaswinder Kaur Saini, before the Ld. Trial Court on 2.08.2024 and the supplementary Challan will be filed against the proclaimed offenders, Opinder Kaur and Jatinder Kaur Gahunia after arresting them in the present case and now both are reportedly found to be in Canada.

In view of the status report, the present petition is disposed of as infructuous.
