1. This order shall dispose of two cases bearing Nos. **RSA-2928-1994** titled as ***“The Municipal Committee, Nilokheri Versus Mulakh Raj”*** and **CWP-3944-2006** titled as ***“Mulkh Raj Versus State of Haryana and others”***.

RSA-2928-1994 (O&M) -2-

2. Mr. Ram Lal Gupta, Advocate, who is representing petitioner in CWP-3944-2006 and respondent in RSA-2928-1994, has made a reference to order dated 22.01.2008 passed in CWP-3944-2006, which is reproduced as hereunder:-

*“Admitted.  
To be heard along with RSA No.2928 of 1994.  
However, interim order dated 10-03-2006 is modified to the effect that the petitioner shall not be relieved till the date of his superannuation.”*

3. He submits that during the pendency of both the cases, petitioner/appellant has retired from service on attaining the age of superannuation. He submits that both the matters have become infructuous.
4. Both the matters are dismissed as having been rendered infructuous.
5. On the request of Mr. Gupta, liberty is granted to the petitioner/appellant to make a representation to the authorities, in case, any claims still subsists.
