The instant petition has been filed under Section 482 Cr.P.C. for quashing of FIR No.927 dated 31.08.2019 (Annexure P-1) under Section 174-A IPC registered at Police Station Thanesar City, District Kurukhethra and the order dated 13.10.2023 (Annexure P-4), passed by the learned Chief Judicial Magistrate, Kurukshetra, by virtue of which the petitioner was declared as proclaimed person, and all consequential proceedings arising therefrom.

2. Learned counsel appearing on behalf of the petitioner submits that subsequent to registration of the FIR in question, the parties had ironed out their differences and arrived at an amicable settlement, and accused-petitioner stands acquitted by the learned trial Court concerned. In support, learned counsel has drawn the attention of this Court to the order dated



23.08.2022 (Annexure P-3) passed by learned Judicial Magistrate First Class/Presiding Officer, Daily Lok Adalat, Kurukshetra. He submits that in the circumstances, continuation of the FIR (Annexure P-1) and consequential proceedings arising therefrom would not serve any useful purpose, and thus, the same be quashed.

3. This Court has heard learned counsel for the petitioner, and perused the relevant material on record.

4. In the light of submissions made by learned counsel representing the petitioner together with the fact that since the parties have arrived at an amicable settlement, and accused-petitioner stands acquitted by the learned trial Court concerned, this Court deems it appropriate to quash the criminal proceedings in the instant case. Accordingly, the petition is **allowed**, and the FIR No.927 dated 31.08.2019 (Annexure P-1), under Section 174-A IPC, registered at Police Station Thanesar City, District Kurukshetra and the order dated 13.10.2023 (Annexure P-4), passed by the learned Chief Judicial Magistrate, Kurukshetra, by virtue of which the petitioner was declared as proclaimed person, and all consequential proceedings arising out of it, are hereby **quashed**.
