In the present petitions, the prayer of the petitioners is that petitioners should be granted the various monetary benefits after they were repatriation to HARTRON.

Learned counsel for the petitioners submits that for the employees, who were also repatriated to the HARTRON, an order has been passed on 29.01.2024 granting them the certain benefits, copy of which has been appended as Annexure P-26 with CM-8375-CWP-2024 in CWP-5740-2023 and keeping in view the letter dated 24.01.2023 (Annexure P-21), the claim of the petitioners be also decided by passing an appropriate speaking order.

Learned counsel for the respondents submits that the petitioners have already been brought back to the HARTRON and they are working with the HARTRON only and with regard to any monetary benefits, if any representation is received from them, the same will be decided in accordance with law by keeping in mind the order dated 24.01.2023 (Annexure P-21) and the said claim of the petitioners will be decided within a period of 8 weeks of the receipt of copy of this order.

Learned counsel for the petitioners submits that keeping in view the statement of learned State counsel, the present petitions may kindly be disposed of having been not pressed any further.
