N.S. SHEKHAWAT, J.

1. The present petition has been filed under Section 407 Cr.P.C. read with Section 482 Cr.P.C. with a prayer to transfer of case tilted as 'Davinder Singh Sharma Vs. Ravi Kumar' (NACT/390/2023) from the Court of Sh. Harpreet Singh, JMIC, Mansa to any other court of competent jurisdiction in the State of Punjab.

2. When this matter came up for hearing on 14.03.2024, the President, District Bar Association, Mansa, was ordered to be impleaded as respondent No.2 and notice of motion was issued.

3. Pursuant to the notice, Mr. N.K. Banka, Advocate has appeared on behalf of respondent No.1 and submitted that respondent No.1 is aged about 77 years and presently he is not active in the practice. He further submits that it has been falsely alleged that respondent No.1 was appearing not only in District Courts, Mansa but also in District Courts, Barnala,

Sangrur and Bathinda. Learned counsel appearing on behalf of respondent

No.1 submits that respondent No.1 never appeared in District Courts, Bathinda, Sangrur and Barnala and false averments have been made by the petitioner in the instant petition

3. Learned counsel appearing on behalf of respondent No.2 submits that Mr. Harpreet Singh Maan, Advocate-President, District Bar Association, Mansa, is a practising lawyer at District Courts, Mansa and he is ready to represent the petitioner in the present case. He has also assured the Court that no member of the District Courts, Mansa would interfere with the proceedings in any manner.

4. In reply to the submissions made by learned counsel for respondent No.2, the petitioner is ready to engage the services of Mr. Harpreet Singh Maan, Advocate- President, District Bar Association, Mansa and does not intend to press the present petition, at this stage.

5. In view of the above, the present petition is disposed of, as not pressed.
