1. Through the instant petition, prayer is made for issuance of direction upon the official respondents to conduct impartial and fair investigation in case FIR No.158 dated 19.7.2023, under Sections 148, 149, 323, and 506 IPC, (Sections 365 and 302 IPC, added lateron), registered at Police Station Pinangwa, District Nuh Mewat, Haryana.
2. Learned counsel for the petitioner submits that despite lapse of seven months, no action has been taken in the FIR(supra) and no person has been arrested by the investigating agency till date.
3. This Court vide order dated 14.3.2024, had directed the State to file the status report with regard to the investigation. In compliance of the order (supra), status report by way of affidavit of DSP, Firojpur Jhirka, District Nuh has been filed. The same is taken on record.
4. In para No.3 of the status report, the detail of investigation

has been mentioned and all the efforts, which the investigating agency had made to arrest the accused, have also been mentioned. The relevant extract of para No.3 reads as under:-

“3. That the local police is making serious, cogent and consistent efforts to arrest the accused, who are absconding from the houses and have concealed themselves to evade police arrest. The details of raids conducted by the local police are mentioned below

a) That the local police has conducted raid on 12.08.2023 at the houses of the accused namely jameel S/o chotta, Tasleems/o jameel, Asif s/o Usman, Imran s/o Sahed sadiks/o Sirdar arrest them, who were not found present to at their houses in village Ted, P.S Pingwa, Dist- Nuh.

b) That the investigating officer conducted raid on 16.09.2023 at the houses of the accused, namely jameel S/o chotta, Tasleems/o jameel Asif s/o Usman, Imran s/o Sahed sadiks/o Sirdar who were found absconding from their houses.

c) That a police raid was also conducted on 23.12.2023 in village Ted P.S Pingwa at the houses of accused namely jameel S/o chotta, Tasleem s/o jameel, Asif s/o Usman, Imran s/o Sahed sadik s/o Sirdar but the accused were not found present at their houses, who were absconding from their houses.

d) That police also conducted raid on 10.01.2024, in village Ted P.S Pingwa at the houses of accused namely jameel S/o chotta, Tasleem s/o jameel Asif s/o Usman, Imran s/o sadik s/o Sirdar but the accused were found present at Sahed not their houses, who were absconding from their houses.

e) That police also conducted raid on 25.01.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were

absconding from their houses.

f) That police also conducted raid on 16.02.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were absconding from their houses.

g) That police also conducted raid on 28.02.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were absconding from their houses.

h) That police also conducted raid on 08.03.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were absconding from their houses.

i) That police also conducted raid on 20.03.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were absconding from their houses.

j) That police also conducted raid on 08.04.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were absconding from their houses.

k) That police also conducted raid on 18.04.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were absconding from their houses.

l) That police also conducted raid on 28.04.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were absconding from their houses.

m) That police also conducted raid on 02.05.2024, in village Ted P.S Pingwa at the houses of accused but the accused were not found present at their houses, who were absconding from their houses.

n) *That police also conducted raid on 06.05.2024, in village Ted P.S Pingwa at the houses of accused, but the accused were not found present at their houses, who were absconding from their houses.*”

5. From the perusal of para No.3, it transpired that out of 9 accused mentioned in the FIR, 2 have already been arrested and final report *qua* them has already been filed and the efforts are being made by conducting raids to arrest the other co-accused.

6. In view of the above specific reply, at this stage, this Court finds that, no further directions are required to be passed in the instant petition, as the investigation is going in its right direction, therefore, the instant petition is, hereby, **closed**, however, with a liberty to the petitioner to re-access this Court in case any grievance is still left.

7. **Disposed** of accordingly.
