HARKESH MANUJA, J. (Oral)

1. By way of present petition filed under Section 482 Cr.P.C., the petitioners pray for quashing of FIR No.23 dated 28.02.2024, registered under Sections 323, 341, 148 and 149 IPC, at Police Station Lehra, District Sangur (Annexure P-1) and all other subsequent proceedings arising therefrom on the basis of compromise dated 08.03.2024 (Annexure P-2).

2. As per the allegations levelled in the FIR, the petitioners after having encircled the complainant inflicted injuries to him with their respective weapons.

3. In pursuance of order dated 19.03.2024 passed by this Court, whereby parties were directed to appear before the Trial Court for getting their statements recorded as regards the veracity of compromise arrived at

between them, report dated 05.04.2024 has been received from the concerned Court, stating that compromise between the parties is genuine, voluntarily, out of free will of the parties. No accused has been declared as proclaimed person.

4. Once, the compromise has been arrived at between the parties without any pressure and respondent No.2 having no objection as regards quashing of FIR as well as all other subsequent proceedings arising out of the same against the petitioners; there does not appear to be any impediment as regards quashing of present FIR qua the petitioners. Even otherwise, in order to maintain peace and harmony between the parties, particularly under the circumstances wherein the alleged offences have no societal interest involved, it would be appropriate to render complete quietus to the aforementioned dispute by quashing the FIR on the basis of compromise entered into between the parties.

5. The parties having settled their dispute so as to live in peace in future, no useful purpose would be served by proceeding further with the criminal proceedings. In the light of above developments, no cause remains for the Trial Court to invest further time and effort in adjudicating this FIR. The compromise in question is even found to be fully in consonance with the direction issued by the Court in ***Kulwinder Singh & Ors. Vs. State of Punjab 2007(3) RCR (Criminal) 1052 and Gian Singh Vs. State of Punjab & Anr., 2012(4) RCR (Crl.) 543.***

6. Thus, in view of the aforesaid facts, accompanied by statements of both the parties as well as keeping in mind the law laid down in the aforementioned judgments, FIR No.23 dated 28.02.2024, registered under Sections 323, 341, 148 and 149 IPC, at Police Station Lehra, District Sangur

(Annexure P-1) as well as all subsequent proceedings arising therefrom are hereby quashed qua the petitioners.

7. Accordingly, petition stands allowed.
