By way of this petition filed under Section 482 Cr.P.C., prayer is made to quash DDR No.11 dated 17.07.2015 registered under Sections 307, 148, 149 of the IPC registered at Police Station Jhabhal as cross case of FIR No.73 dated 16.07.2015 registered under Sections 452, 323, 148, 149 of the IPC and Section 25/27/54/59 Arms Act registered at police Station Jhabhal, District Tarn Taran.

2. Learned counsel contends that it was a cross case. The cross case bearing FIR No.73 dated 16.07.2015 as referred above has already been quashed by this Court vide order dated 25.07.2019 passed in CRM-M-23957-2017 (O&M). Copy of which has been placed on record. That cross case was also quashed on the basis of compromise between the parties.

3. Compromise (Annexure P-4) is on record. It is revealed further that vide order dated 24.09.2018, parties were directed to appear before the learned

Trial Court/Illaqa Magistrate for getting their statements recorded regarding the compromise. The report of learned Trial Court has already been received which confirms that compromise has been effected which is voluntarily in nature. The report is also accompanied by the statements of respondent Nos.2 & 3 who are the injured of the case.

4. Having regard to all the above facts and circumstances, this petition is allowed and DDR No.11 dated 17.07.2015 registered under Sections 307, 148, 149 of the IPC registered at Police Station Jhabhal in cross case FIR No.73 dated 16.07.2015 registered under Sections 452, 323, 148, 149 of the IPC and Section 25/27/54/59 Arms Act registered at police Station Jhabhal, District Tarn Taran and all subsequent proceedings arising therefrom on the basis of compromise (Annexure P-4), are quashed qua the petitioners.
