By way of present petition filed under Section 438 Cr.P.C, the
petitioners seek anticipatory bail in case FIR (Annexure P-1) as under: -

2. Learned counsel for the petitioner submits that in compliance to the order dated 23.05.2024, the petitioner has joined the investigation.
3. During the course of hearing on 23.05.2024, following order had been passed: -

“ Learned State counsel seeks some time for verification of Annexure P-8 to Annexure P-18 by the Investigating Officer and on instructions from SI Umed Singh seeks more time for filing additional affidavit.



2. *Needful be done on or before the next date of hearing with an advance copy to the opposite counsel.*

3. *In the meanwhile, the petitioners are hereby directed to join investigation within seven days from today and in the event of their arrest, they are ordered to be released on interim bail on their furnishing personal/surety bonds to the satisfaction of the Arresting Officer/Investigating Officer. They shall also abide by conditions as envisaged under Section 438(2) Cr.P.C.*

4. *List on 16.07.2024”*

4. Learned State counsel on instructions from S.I. Umed Singh informs the Court that the petitioners have joined the investigation and are neither required for further investigation nor for any custodial interrogation.

5. Keeping in view the above submissions made by learned State counsel and the fact that the petitioners had joined the investigation consequent to the order dated 23.05.2024 passed by this Court, interim bail granted vide order dated 23.05.2024 is hereby confirmed, subject to conditions as envisaged under Section 438(2) Cr.P.C. Further the petitioners are directed to join investigation as and when required in future by way of written notice for such purpose to be served by Investigating Officer of this case upon them; they will not tamper with the evidence nor will influence the witnesses and will not leave the country without prior permission of the Court.



7. It is made clear that anything contained hereinabove shall not be construed to be an expression of opinion on the merits of the case.
