1. This is a Civil Writ Petition filed under Article 226/227 of the Constitution of India seeking issuance of an appropriate writ, order or direction especially in the nature of certiorari quashing the impugned final result dated 29.02.2024 (Annexure P-11).

2. Learned counsel for the petitioner has submitted that for the grievances raised by the petitioner, the petitioner had given a representation dated 04.07.2022 (Annexure P-13) and at this stage, the petitioner would be satisfied, in case, competent authority of the respondent considers the same, in accordance with law, within a specified time frame and in case, the plea raised by the petitioner is found to be meritorious, then, grant the appropriate relief to the petitioner.

3. Learned counsel appearing for the respondent has submitted

that competent authority of the respondent would consider the said representation dated 04.07.2022 (Annexure P-13), filed by the petitioner, in accordance with law and the same would be done within a period of three months from the date of certified copy of this order.

4. Keeping in view the above-said facts and circumstances, the present petition is disposed of, with a direction to competent authority of the respondent to consider the representation dated 04.07.2022 (Annexure P-13) filed by the petitioner within a period of three months from the date of receipt of the certified copy of this order and in case, competent authority of the respondent is of the view that the plea raised by the petitioner is meritorious, then, the appropriate relief be granted to the petitioner, as expeditiously as possible. In case, competent authority of the respondent is of the view that the plea raised by the petitioner is meritless, then, a speaking order rejecting the claim be passed within the aforesaid period of three months.

5. It is made clear that this Court has not opined on the merits of the case and competent authority of the respondent would consider and decide the matter independently, in accordance with law.
