DEEPAK GUPTA, J.(ORAL)

On 08.04.2024, following order was passed:

“By way of present petition filed under Section 438 Cr.P.C., petitioner prays for grant of anticipatory bail in case FIR No.26 dated 23.02.2024 under Section 15(c) of Narcotic Drugs and Psychotropic Substances Act, 1985 (for short, ‘the NDPS Act’) (later-on added offence under Section 29 of the NDPS Act), at Police Station Sadar Faridkot, District Faridkot.

As per allegations, co-accused Sukhjinder Singh was apprehended by the Police Party on 23.02.2024 and recovery of 50 kg of Poppy Husk was effected from him. During interrogation, said Sukhjinder Singh disclosed that he had been contacted by the petitioner and co-accused – Lovepreet Singh @ Pavittar Singh Gill, who offered him ₹30,000/- per turn for bringing Poppy Husk and Opium from Assam to Punjab. It is petitioner – Mandeep Singh, who used to arrange the seller. It is further alleged that later on petitioner got transported 4 Kg of Opium and 50 Kg of Poppy Husk from Sukhjinder Singh by making direct payment by him to the sellers. On 21.02.2024, he had brought that consignment from Assam to Punjab. The Opium of 4 Kg had already been taken away by petitioner; whereas he (Sukhjinder Singh) was apprehended with 50 Kg of Poppy Husk.

Learned counsel for the petitioner contends that the petitioner has been falsely implicated simply on the basis of disclosure statement of

co-accused; that the petitioner has never indulged in any such activity, pertaining to the NDPS Act and that he is ready to join the investigation. It is further submitted that co-accused Lovepreet Singh @ Pavittar Singh Gill has already been given the benefit of interim anticipatory by this Court vide order dated 20.03.2024 passed in CRM-M-14344-2024.

Notice of motion.

Mr. Sahil R. Bakshi, AAG, Punjab, accepts the notice on behalf of the respondent- State. Copy of paper book be supplied to him during the course of day.

To be heard alongwith CRM-M-14344-2024 on 02.05.2024.

Let detailed status report be filed on or before the date fixed.

In the meantime, in case of his arrest, the petitioner shall be released on interim bail subject to the satisfaction of the Arresting Officer/ Investigating Officer. However, it is further directed that the petitioner shall join the investigation as and when so required by the Investigating Officer. He shall not contact any person associated with the case to dissuade him from the investigation in any manner whatsoever and nor shall leave the country without prior permission of the Court. He shall further comply with the conditions stipulated in Section 438(2) Cr.P.C. ”

Today learned State counsel, on instructions from ASI Chamkaur Singh submits that petitioner has since joined the investigation and is not required for custodial interrogation.

Having regard to the aforesaid facts and circumstances, but without commenting anything further on the merits of the case order dated 08.04.2024 is hereby made absolute, whereby petitioner was granted interim anticipatory bail.

However, the petitioner shall continue to join the investigation as and when called upon to do so by the Investigating Agency and shall abide by the conditions of Section 438 (2) Cr.P.C.
