AWARD OF LOK ADALAT BENCH NO.4

On 02.08.2024, the following order was passed:-

“Respondent No.3 is present alongwith her brothers. The claim petition was filed under Section 163-A of the Motor Vehicles Act. After making calculation, as per the provisions of Section 164 of the said Act, adding interest at the rate of 3%, the total amount payable comes to Rs.2,40,000/-. Counsel for the appellants and respondent No.3 are agreeable that the above said amount be disbursed in the following manner:-

Rs.50,000/- each be paid to appellants No.1 to 4 and Rs.40,000/- be paid to respondent No.3-Sudesh Rani-widow. The proposal form has been signed by counsel for the appellants and also by respondent No.3.

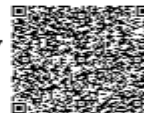
Learned counsel for respondent No.2 seeks an adjournment to get instructions.

Adjourned to 20.08.2024.”

Mr. Deepak Arora, Advocate for the appellants and respondent No.3-Sudesh Rani signed the consent proposal on 02.08.2024, showing willingness to accept an amount of Rs.2,40,000/-(Rupees Two Lakhs Forty Thousand Only) towards full and final settlement of the claim in the present appeal.

Transport Corporation has also signed the said statement today, accepting

the proposal made by the counsel for the appellant and respondent No.3-Sudesh Rani.

Accordingly, we dispose of this case with a direction to respondent No.2-Himachal Road Transport Corporation to deposit five cheques, four for Rs.50,000/-(Rupees Fifty Thousand Only) each favouring appellants No.1 to 4 and one for Rs.40,000/- (Rupees Forty Thousand Only) favouring respondent No.3-Sudesh Rani, with the office of the Lok Adalat of the High Court on or before 29.10.2024. Failing compliance of the order, interest @ 9% per annum shall follow on this amount till payment from the date of this order. The appellants' counsel may collect the cheques from the office of the Lok Adalat after retaining the photocopy of the cheque/draft bearing signatures of the Counsel.
