SANDEEP MOUDGIL, J (ORAL)

1. The jurisdiction of this Court under Articles 226/227 of the Constitution of India has been seeking writ in the nature of Mandamus directing respondent No.2 not to harass the petitioners with further direction to respondent No.3 to protect the lives and liberty of the petitioners from their family members.
2. Learned State counsel has filed an affidavit of Mr. Gurdev Singh, PPS, Deputy Superintendent of Police, Sub Division Malerkotla along-with copies of statements of petitioners, CDRs and tower locations of mobile numbers (Annexures P-1/T, P-2/T and P-3 respectively).
3. Statement of petitioner No.1-Mohammad Ahmed is relevant, which reads as under:-

"Statement of Mohammad Ahmed son of Adim Ud Din, resident of Gonda, Police Station Basantrai, District Gudda (harkhand) now residing Grib Nagri, Near Badi Eidgah Road, Malerkotla, now residing Barkatpura, Police Station Sandaur, aged about 24 years, Mobile No.81712-94302.

Stated that I am resident of above said address and doing the work as Imam (Molvi) in Mosque at Mohalla Ariyan Wala, near Sirhindi Gate, Malerkotla. On 11th April 2024, I got married to Hajra daughter Mohammad Kurshid resident of village Barkatpura of my own free will and without the consent of my parents. But my parents, relatives and brothers and sisters were not happy with this marriage and on 10th April 2024, they assaulted me in the Mosque at village Barkatpura. After 11th April 2024, my parents and siblings have not committed any misbehavior with me or my wife till date. Now I am happily living as husband and wife with my wife Hajra in my in law's room at village Barkatpura. Now there is no threat to me and my wife's life and liberty from my parents and if my parents and siblings beat or harm me in the future, I will move an application at Police Station, Sandour to initiate legal action. I had got recorded my statement before ASI Davinder Singh of Police Station Sandaur and at that time I needed protection. But now my parents got recorded their statement that I can live as husband and wife with my wife Hajra and they have no objection about my marriage at present. I have got recorded my statement in the presence of my wife and respectable persons of Village Barkatpura, the same is read and correct."

4. From perusal of afore-said statement, it is evident that they are living happily as husband and wife and there is no threat to their lives and liberty from their parents and relatives.
5. Faced with the situation, learned counsel for the petitioners prays for withdrawal of the present petition.
6. Prayer is accepted.
7. Dismissed as withdrawn.
